By letter to the U.S. Nuclear Regulatory Commission (NRC) dated July 20, 2010, Uranium One Inc. (Uranium One), a Canadian Corporation, submitted an Application for Change of Control and Ownership for its Irigaray and Christensen Ranch uranium *in-situ* recovery project in Johnson and Campbell Counties, Wyoming, to JSC Atomredmetzolotato (ARMZ). The Irigaray and Christensen Ranch facilities are licensed under Source Materials License SUA-1341 and are located within the Powder River Basin of Wyoming, approximately 5 miles west of the Pumpkin Buttes. Uranium One requested that NRC consent to the change in control and ownership as is required under 10 CFR 40.46. The NRC is notifying you of this action, as you may have an interest.

On June 8, 2010, Uranium One entered into a Purchase and Subscription Agreement with ARMZ, and its wholly owned subsidiaries Effective Energy N.V. and Uranium Mining Corporation, wherein ARMZ will acquire not less than 51 percent of Uranium One's common shares. ARMZ is presently directly and indirectly owned by the State Atomic Energy Corporation Rosatom (Rosatom). Its activities are regulated by Russian Federal Law and by regulatory legal acts of the President of the Russian Federation and the Government of the Russian Federation. Consummation of the transaction would result in the indirect change of control of the Applicant and license SUA-1341 from Uranium One, Inc. to Rosatom, through ARMZ.

A Notice of Application from Uranium One USA, Inc., for Consent to an Indirect Change of Control for Source Material License SUA-1341 to JSC Atomredmetzoloto, Opportunity to Provide Comments and to Request a Hearing will be published in the *Federal Register* in the near future.
