

The purpose of this modification is to provide incremental funding in the amount of \$100,000, which increases the task order obligated amount from \$323,037 to \$423,037.

Accordingly, the following change is hereby made:

1. Section A CONSIDERATION AND OBLIGATION—COST PLUS FIXED FEE (JUN 1988), Paragraph (c) is hereby deleted in its entirety and replaced with the following:

- (c) The amount presently obligated with respect to this order is \$423,037, of which the sum of \$ [REDACTED] represents the estimated reimbursable costs, and of which [REDACTED] represent the fixed fee. The Contractor shall not be obligated to incur costs above this ceiling/obligated amount unless and until the Contracting Officer shall increase the amount obligated.
