SUBJECT: UPDATE ON STANDARD LICENSE CONDITIONS IN
NUREG-1556, VOLUME 20, APPENDIX E, REQUIRING AN
OFFICE OF MANAGEMENT AND BUDGET CLEARANCE

This memorandum is in response to questions raised by the Regions in regards to the use of certain standard license conditions in NUREG-1556, Volume 20, Appendix E, and the appropriate Office of Management and Budget (OMB) clearance. Volume 20 states that, "Licensing staff should not use the recordkeeping portion of condition nos. 22, 23, 26, 32, 132, 133, 164, or 165.I until notified that an OMB clearance has been obtained."

This confirms that the U.S. Nuclear Regulatory Commission has the OMB clearance to allow staff to use the recordkeeping portion for standard license conditions 22, 23, 26, 164, and 165.I. These standard license conditions were included in the most recent revision for OMB 3150-0017 dated December 3, 2008.

There is no OMB clearance for standard license conditions 32, 132, and 133. The OMB clearances for the three license conditions will be addressed in the next revision to OMB 3150-0017 scheduled for 2011.

The future update of NUREG-1556, Volume 20 will reflect this change. Immediate action is not required. The Regions should make the changes to any affected licenses as part of regular license renewals and amendments.
