

The purpose of this letter is to provide updated schedule information for Request for Additional Information (RAI) questions that are related to the plant footprint change for the Bell Bend Nuclear Power Plant (BBNPP) site.

As the staff is aware, PPL Bell Bend, LLC (PPL) is revising the footprint of the proposed BBNPP within the existing project boundary in order to avoid impacts to wetlands on the BBNPP site. This relocation will change certain site-specific characteristics which have been previously identified within the BBNPP Combined License Application (COLA), and will also impact some previous and pending Safety and Environmental RAI responses. Final site characterizations and their associated COLA impacts are currently being developed. As they are finalized for affected COLA portions, supplemental COLA submittals will be submitted to the staff, including impacted RAI responses.

The schedule for submitting each identified supplement was provided under separate correspondence (Reference 1), and was recently updated for near-term changes (Reference 2). In combination, these references supersede the previously docketed projected submittal dates for pending RAIs. PPL will update the staff in a timely manner should the need for further revisions to the supplement submittal schedule arise.

An enclosure is included with this letter to provide appropriate cross reference information for the footprint-related RAIs. Included in the enclosure are the impacted RAI number, RAI transmittal correspondence identifier, impacted RAI question numbers, previously identified response submittal dates and associated submittal correspondence identifier.


The only new regulatory commitment in this letter is to provide the supplemental submittals in accordance with the enclosed schedule.
