The purpose of this letter to provide schedule information for the request for additional information (RAI) identified in NRC correspondence to PPL Bell Bend, LLC (PPL)(Reference 1). This RAI addresses the Raw Water Supply System as discussed in Chapter 9 of the Final Safety Analysis Report (FSAR) and submitted in Part 2 of the Bell Bend Nuclear Power Plant (BBNPP) Combined License Application (COLA).

As the staff is aware, PPL Bell Bend is revising the footprint of the proposed BBNPP within the existing project boundary. This re-location may change site-specific characteristics, such as conceptual design of the Raw Water Supply System, piping lengths, design flow rates and heads of pumps. RAI No. 96 Question 09.02.05-16 is impacted by the re-location of the plant physical siting.

Since this re-location will result in additional information being submitted to the NRC in accordance with the plant footprint re-location schedule information provided in Reference 2, information necessary to address these questions will be included in the submitted changes to FSAR Section 9.2.9. PPL will keep the NRC staff apprised of changes to this schedule in a timely manner.

The only new regulatory commitment in this letter is to submit the responses to RAI No. 96 in accordance with the most recent docketed schedule information for BBNPP FSAR 9.2.9 plant footprint change schedule.
