


The purpose of this modification is to 1) Extend the Period of Performance from July 17, 2010 to December 31, 2010 at no additional increase in the rates currently being provided in the contract 2) Deobligate funds in the amount of (\$143,000.00) thereby decreasing the total obligations from \$215,311.00 to \$72,311.00 and 3) add the following clause "§2017.204 Contracts". Accordingly the contract is modified as follows:

Refer to Section B.2 entitled "CONSIDERATION AND OBLIGATIONS - DELIVER ORDERS (JUN 1988)" paragraph (b) first sentence is deleted in its entirety and replaced with the following:

"(b) The amount presently obligated with respect to this contract is \$72,311.00"

Refer to Section B.3 entitled "DURATION OF CONTRACT PERIOD (MAR 1987)" first sentence is deleted in its entirety and replaced with the following:

"This contract shall commence on July 18, 2008 and will expire on December 31, 2010"

The following Clause is hereby added:

"CHAPTER 20 - NUCLEAR REGULATORY COMMISSION

§2017.204 Contracts

(a) The contracting officer may approve non-competitive extensions, within the limits of his/her delegation, to five-year contracts up to a total of an additional 6 months for the purpose of completing the competitive process for a follow-on contract if the request for procurement action for a follow-on or replacement contract was received in the Division of Contracts and Property Management not less than 6 months before the end of the fifth year.

(b) Other extensions beyond five years must be approved by the Competition Advocate."
