On July 14, 2010, the Department conducted an inspection of your facilities and operations as they relate to radiation safety and compliance in accordance with Title 17, the California Code of Regulations and the California Health and Safety Code. The inspection consisted of a review of the documents that must be available at California jobsites when work is performed under your reciprocity authorization.

TechCorr activities were observed at the Ameron International, Arrow Plant, 12455 Arrow Route, Etiwanda, CA 91739.

During the inspection, jobsite documents were available and reviewed. Within the scope of the inspection, no items of noncompliance were found.

The Department has the following recommendations, comments and observations, which we believe will contribute to your ongoing radiation safety program.

- 1) Ensure that all labels and markings, such as the "RQ" sticker are legible on the "Type B" packaging.
 - 2) You should ensure that your copy of Title 17 of the California Code of Regulations is up to date that your copy of Title 10 of the Code of Federal Regulations, Part 20 is the January 1, 2005 version.
