The purpose of this modification is to reflect an updated level of effort for task 19, increasing the task order ceiling by \$400,003.99 from \$4,269,970.43 to \$4,669,974.42. The increase in ceiling will provide assistance to the Office of New Reactors (NRO) with the analysis of the documentation of the construction inspection processes associated with the Construction Inspection Program. In addition, the Office of Small Business and Civil Rights needs assistance with the documentation of functions and activities for the Small Business Program and to identify functional and system requirements for automation opportunities. This work is to be performed under the "ad hoc" activities under the statement of work; therefore the statement of work does not need to be modified. Attached is a revised price schedule for this task.

In addition, this modification increases the obligated amount by \$245,000 from \$4,227,275.90 to \$4,472,275.90. The following is a summary of obligations from date of award until the date of this action:
