The purpose of this modification is to add funds in the amount of \$50,000 and to add a paragraph d. under B.1.

(d) The amount presently obligated with respect to this contract is **\$150,000**. The Contracting Officer may issue orders for work up to the amount presently obligated. This obligated amount may be unilaterally increased from time to time by the Contracting Officer by written modification to this contract. The obligated amount shall, at no time, exceed the maximum ordering limitation (MOL) as specified in paragraph a above. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this contract. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk.

A summary of obligations under this contract, from date of award through this modification, is given below:

Total FY10 obligation amount: \$150,000
Total obligation amount: \$150,000

This modification obligates \$50,000 FY10 funds.

All other terms and conditions under this contract, including the current ceiling of \$174,887.60, remain unchanged.
