During August 2-5, 2010, the U. S. Nuclear Regulatory Commission (NRC) conducted a security inspection at your Idaho State University AGN-201 Research Reactor facility. The inspection examined activities conducted under your license as they relate to security and compliance with the Commission's rules and regulations and with the conditions of your license. The inspector reviewed selected procedures and records, observed activities, and interviewed personnel.
