In accordance with Reference 2, per the clarifications made in Reference 3 describing our conservative, measured approach to restart one line of production at a time, and in accordance with your request in Reference 4, Nuclear Fuel Services, Inc. (NFS) is notifying NRC or our readiness to start the use of supporting equipment in Building 301. In Reference 5, NFS provided NRC with an outline of our plans to use supporting equipment in Building 301. NFS respectfully requests NRC commence their review on August 30, 2010 of our readiness to start the following processes in Building 301: Ammonium Diuranate (ADU) Precipitation and Filtration, Calciner and Product Unloading Station, Heel Removal Station, and the Sorting Station.
