#### Status of Recommendations

Recommendation 2:

Require annual, unannounced, full-scale evacuation drills, including mustering and accountability assessments, held at all headquarters and regional complexes.

Agency Response Dated July 30, 2010:

As noted in the agency's response dated February 25, 2010, full-scale emergency evacuation drills, including assembly and accountability (A&A), were conducted in calendar year 2009 at all headquarters and regional complexes, with the exception of Region II.

Region II moved into the Marriott Marquis One Tower located in the Peachtree Center Complex on April 12, 2010. Region II officials have asked General Services Administration (GSA) and Federal Protective Service (FPS) officials to provide them a specific date for a fire drill at their new location. A response from the GSA and FPS is pending at this time. Region II will conduct an A&A of their occupants during the fire drill evacuation.

Targeted Completion Date: August 31, 2010.

OIG Analysis:

The proposed corrective action addresses the intent of this recommendation. This recommendation will be closed when OIG receives verification that the Region II evacuation drill has been completed.

and determined that the maps are located consistently on every floor. This recommendation is therefore closed.
