Issuance of Palo Verde Nuclear Generating Station, Units 1, 2, and 3, Safety Evaluation Report (SER) with Open Item

On August 6, 2010, the staff issued the SER with Open Item related to the Palo Verde Nuclear Generating Station, Units 1, 2, and 3, (Palo Verde) license renewal application. By letter dated December 11, 2008, and supplemented by letter dated April 14, 2009, Arizona Public Service Company submitted an application requesting an extension of the Palo Verde operating licenses for an additional 20 years. The SER has one open item regarding issues associated with the applicant's metal fatigue analyses. The staff is scheduled to meet with the Advisory Committee on Reactor Safeguards subcommittee on September 8, 2010, to discuss the SER with Open Item.

Public Meeting with Boiling Water Reactor (BWR) Owners Group

On August 10 and 11, 2010, the staff held a public meeting with representatives of the BWR Owners Group to discuss the Owners Group's activities to address BWR emergency core cooling system strainer performance in light of lessons learned from Generic Safety Issue 191, Pressurized Water Reactor Sump Performance.

Public Meeting to Discuss Status of 50.46(b) Rulemaking

On August 12, 2010, the staff conducted a public meeting to discuss the status of the 50.46(b) rulemaking and the industry's project plan to provide plant-specific Emergency Core Cooling Systems safety assessments. These assessments are necessary to confirm current plant safety in light of recent research findings which identified previously unknown embrittlement mechanisms.

Publication of Regulatory Guide (RG) 1.216, "Containment Structural Integrity Evaluation for Internal Pressure Loadings Above Design-Basis Pressure"

On August 10, 2010, RES staff published RG 1.216. This RG describes methods considered by NRC to be satisfactory for predicting the internal pressure capacity for containment structures above the design-basis accident pressure, demonstrating containment structural integrity related to combustible gas control, and demonstrating containment structural integrity through an analysis that specifically addresses the Commission's performance goals related to the prevention and mitigation of severe accidents. Publication of Draft Regulatory Guide 1228 (DG-1228) "Standard Format and Content of License Termination Plans for Nuclear Power Reactors"

On August 10, 2010, RES staff issued DG-1228 to provide an opportunity for public comments. The draft guide is a proposed revision 1 of RG 1.179 that describes methods acceptable to the NRC staff for the preparation of license termination plans for nuclear power reactors. Research Operations Management Application

On July 16, 2010, as a result of an 8(a) non-competitive solicitation, a hybrid (time-and-materials and firm-fixed-price) indefinite delivery indefinite quantity contract (NRC-04-10-145) was awarded to KMC, Inc. of McLean, Virginia. The objective of the contract is to provide NRC-wide Research Operations Management Application (ROMA) support, maintenance, and implementation, and ROMA training for NRC offices. The period of performance is July 16, 2010, through July 15, 2011, with a 1-year option period. The total estimated ceiling cost is \$950,000.00, inclusive of the option.

Digital Data Management System

On July 16, 2010, a competitive General Services Administration (GSA) schedule order (NRC-DR-21-10-496) was awarded to Avaya Government Solutions of Fairfax, Virginia to provide operations and maintenance support for the Digital Data Management System installations at the Rockville Atomic Safety and Licensing Board (ASLB) hearing room and the Las Vegas hearing facility. The contractor will also support the application installations in the Consolidated Test Facility, the Test and Acceptance Environment, and/or the Contractor development lab. In addition, the contractor will provide day-to-day hearing support for hearings held at the Rockville ALSB hearing room, the Las Vegas hearing facility, and remote locations or other hearing sites throughout the United States and its territories. The period of performance is September 15, 2010, through September 14, 2011, with four 1-year option periods. The total estimated ceiling cost is \$9,164,057.14, inclusive of all options.

Custodial Management Services for White Flint Buildings

On July 28, 2010, as a result of a set-aside for small disadvantaged veteran owned business competitive acquisition, a fixed price contract (NRC-10-10-373) was awarded to Alcazar Trades, Inc. of San Antonio, Texas for custodial management services for the White Flint Complex. The period of performance for this contract consists of a transitional period from August 1, 2010, through August 31, 2010, with the incumbent vendor, and a base period of 6 months from September 1, 2010, through February 28, 2011, with four 1-year option periods. The total estimated ceiling cost is \$6,259,053.48, inclusive of options. NRC was notified by the Government Accountability Office on August 11, 2010, that a protest was filed by the incumbent vendor, Proactive LLC.

Contract Oversight and Policy Development Support Services

On August 2, 2010, as a result of a noncompetitive (8a) set aside, a fixed-price contract (NRC-10-10-397) was awarded to Suntiva, LLC of Falls Church, Virginia for contract oversight and policy development support services. The contract period runs from August 2, 2010, to August 1, 2011, with two 1-year option periods. The total estimated ceiling cost is \$990,207.00, inclusive of all options.

Long Distance Telecommunications Services

On August 10, 2010, as a result of a competitive GSA Network Universal requirement, NRC selected MCI Communications Services Inc., doing business as Verizon Business Services, to provide transition service for NRC's long-distance telecommunications services currently being provided to NRC under the GSA Federal Technology Services 2001 contract. The Office of Information Services will enter into an Interagency Agreement with GSA to provide funding so that GSA can award the order on behalf of the NRC. The order to be awarded by GSA will consist of a base period from the date of award through March 31, 2011, with two 1-year option periods. The total estimated ceiling cost is \$8,674,562.97, inclusive of all options.

Verbatim Captioning Services

On August 12, 2010, as a result of a small business set-aside competitive action, a fixed price indefinite delivery indefinite quantity contract (NRC-21-10-498) was awarded to National Capitol Contracting, LLC for on-site captioning, remote captioning, captioning from DVD and electronic transcripts. The period of performance is from August 25, 2010, through August 24, 2011, with two 1-year option periods. The total estimated ceiling cost is \$514,561.20, inclusive of options.
