Dear Ms. Haney:

In accordance with 10 CFR 76, the United States Enrichment Corporation (USEC) hereby submits Revision 123 to the USEC-01 certification documents for the Paducah Gaseous Diffusion Plant. The annual update is required by 10 CFR 76.68(b). Revision 123 includes the following changes:

- Revision 123 incorporates changes to the Safety Analysis Report (SAR) that have been reviewed in accordance with 10 CFR 76 and have been determined to not require prior NRC approval. Revision 123 is effective August 10, 2010.
- Revision 123 incorporates changes to the Emergency Plan, Fundamental Nuclear Materials Control Plan (FNMCP), and Gaseous Diffusion Plant Security Program (GDPSP). These changes have been reviewed in accordance with 10 CFR 76 and have been determined to not require prior NRC approval. Revision 123 is effective August 10, 2010.

Revision bars are provided in the right-hand margin to identify changes.

Revision 123 to the FNMCP and GDPSP contains certain trade secrets and commercial and financial information exempt from public disclosure pursuant to Section 1314 of the Atomic Energy Act of 1954 (AEA), as amended, and 10 CFR 2.390 and 9.17(a)(4). In accordance with 10 CFR 76.33(e) and 2.390(b), the Revision 123 changes to these plans are being submitted under separate cover (USEC letter GDP 10-0034).
