Mr. Burrows;

Thank you for the reminder. While I have been ill for the past two weeks, I do not believe it is a good excuse for not getting back to you with our schedule for responding to the Technical reviewers' "Requests for Additional Information" (RAIs) sooner. Based on the analysis of both sets of RAIs, our consultants and staff have provided me their best estimates for completing the responses to the RAIs. Many of the RAIs will be addressed by early-to-mid August 2010. Several RAIs that require additional analysis will likely not be available until early September 2010. I am aware that you would prefer to receive all the RAIs at the same time. However, in the interest of providing you and staff the opportunity to review our responses sooner rather than later, I ask that you consider allowing us to submit the RAI responses in two or three submittals. I certainly understand if your reply is negative. However, it seems that a partial submittal of responses would allow time for staff review while many of the issues are still relatively fresh in their minds. Regardless of your decision on this matter, please be assured that Powertech is busy working to respond to all of the TR RAIs and will submit our responses at the earliest possible time.

Please let me know if you need any additional information regarding scheduling at this time. Thank you again for the reminder.
