14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purpose of this modification is to exercise OPTION YEAR 1, thereby increasing the ceiling of the contract by \$320,535.20, from \$321,892.80 to \$642,428.00 and extending the period of performance of the contract through 9/20/2011. Accordingly the contract is modified as follows: (1) The first sentence under paragraph (a) under Section B.1 CONSIDERATION AND OBLIGATION-TASK ORDERS (AUG 1989) ALTERNATE 1 (JUN 1991) is revised to read: "(a) The Maximum Ordering (MOL) for products and services ordered, delivered and accepted under this contract is \$642,428.00..." (2) The PERIOD OF PERFORMANCE under the contract is revised to read: "9/21/2009 - 9/20/2011."  
Contract Ceiling: \$642,428.00 (Changed)  
Contract Obligations: \$50,000.00 (Unchanged)  
Period of Performance: 9/21/2009 - 9/20/2011 (Changed)
