The following changes are hereby incorporated into Order No. DR-09-07-652:

1. Option Year 3 (August 2, 2010 – August 1, 2011) is hereby exercised in accordance with Clause B.5 – 52.217-9 Option to Extend the Term of the Contract (MAR 2000).
2. Clause B.1 – Consideration and Obligation – Labor hours is hereby revised as follows:
 - The first sentence of paragraph (a) is hereby revised to read as follows:

“(a) The total estimated amount of this contract (ceiling) for the products / services ordered, delivered, and accepted under this contract is \$229,073.60.”
 - The first sentence of paragraph (b) is hereby revised to read as follows:

“(b) The amount presently obligated with respect to this contract is \$219,548.80.”
3. The order ceiling is hereby increased by \$64,644.00 from \$165,429.60 to \$229,073.60
4. The order obligation is hereby increased by \$55,000.00 from \$164,548.80 to 219,548.80.
