Reference Task Order NSIR-001 under Contract NRC-10-07-414.

The purpose of this modification is to (1) extend the period of performance of this task order, (2) increase the task order ceiling, (3) revise the price schedule, and (4) add incremental funding, as follows:

1. The period of performance end date of this task order is extended from September 20, 2010, to September 20, 2011, an extension of one year, in order to continue the effort under this task order during option year three of Contract NRC-10-07-414. The revised period of performance is from October 30, 2007, through September 20, 2011.
2. Increase the ceiling of Task Order NSIR-001 by \$145,388.62, from \$339,481.09 to \$484,869.71.
3. An estimated price schedule showing revised Option Year Two and new Option Year Three, as well as the total task order ceiling in the amount of \$484,869.71, is attached.
4. Add incremental funding in the amount of \$42,000.00, thereby increasing the obligated amount from \$339,481.09 to \$381,481.09.
