SUBJECT: SUMMARY OF THE JULY 22, 2010, CATEGORY 2 MEETING  
REGARDING THE NATIONAL FIRE PROTECTION ASSOCIATION  
STANDARD 805 FREQUENTLY ASKED QUESTION PROCESS

On July 22, 2010, the U.S. Nuclear Regulatory Commission (NRC) staff held a meeting with stakeholders and the public to discuss Frequently Asked Questions (FAQs) at plants that are adopting National Fire Protection Association (NFPA) Standard 805. Licensees and the NRC staff discussed the list of currently open FAQs. The participants determined that both industry stakeholders and the NRC staff needed to continue to work on the remaining open FAQs.

Licensees presented and discussed a revision of FAQ 07-0038, which has to do with multiple spurious actuations. The licensees stated that the new revision incorporates NRC comments, information from pilot plants' license amendment requests (LARs), and pilot answers to NRC Requests for Additional Information.

The NRC staff discussed the status of FAQ 08-0053 which deals with the categorization of Kerite cables. The staff noted that the draft test report from last summer's cable testing is expected to be released by the end of July.

The NRC staff presented and discussed a revision of FAQ 08-0056, which has to do with radioactive release transition. The details of the FAQ are publicly available at the accession number identified below. Licensees expressed concern regarding the acceptability of the proposal by the NRC's Office of General Council (OGC). The NRC staff stated that they expected to involve the OGC in the final approval of the FAQ resolution.

Licensees introduced new FAQ 10-0058, which is the industry LAR template. The licensees stated that this version of the template was the same as the last version that was sent to the NRC. Both the licensees and the NRC staff agreed that the template should not contain technical guidance, and thus this FAQ has a lower priority than other open FAQs that will provide technical guidance to licensees (e.g., FAQs 07-0030, 07-0038, 09-0056).
