The purpose of this modification is to (1) exercise Option Year 3 of the contract, thereby extending the period of performance of the contract from September 30, 2010 to September 30, 2011. (2) increase the ceiling amount of the contract by \$97,509.12 from \$281,485.80 to \$378,994.92 (3) increase the amount obligated by \$16,400.00 from \$281,485.80 to \$297,885.80. Accordingly, the contract is modified as follows:

(1) Refer to Section B.2 entitled, "CONSIDERATION AND OBLIGATION – DELIVERY ORDERS (JUN 1988)", paragraphs (a) and (b), first sentence are deleted in their entirety and substituted with the following in lieu thereof:

"(a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$378,994.92.

(b) The amount presently obligated with respect to this contract is \$297,885.80"

(2) Refer to Section B.5 entitled, "DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 2 (MAR 1987)", delete paragraph in its entirety and substitute with the following in lieu thereof:

"This contract shall commence on October 1, 2007 and will expire on September 30, 2011. The term of this contract may be extended at the option of the Government for 1 additional 1-year option."

A summary of obligations from the date of award through the date of this action is provided as follows:
