SUBJECT: REQUEST FOR WITHHOLDING INFORMATION FROM PUBLIC DISCLOSURE RE: PROPOSED LICENSE AMENDMENT FOR EXTENDED POWER UPRATE (EPU) OPERATION, STEAM DRYER MODIFICATIONS – NINE MILE POINT NUCLEAR STATION, UNIT NO. 2 - (TAC NO. ME1476)

Dear Mr. Belcher:

By letter dated July 30, 2010, you submitted an affidavit dated July 28, 2010, executed by Mr. Alan J. Bilanin of Continuum Dynamics, Inc. (C.D.I.), requesting that the information contained in the following documents be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Part 2, Section 2.390:

C.D.I. Report No. 10-12P, "Design and Stress Evaluation of Nine Mile Point Unit 2 Steam Dryer Modifications for EPU Operation," Revision 0; and

Structural Integrity Report No. 1000814.401, "Flaw Evaluation of Indications in the Nine Mile Point Unit 2 Steam Dryer Vertical Support Plates Considering Extended Power Uprate Flow Induced Vibration Loading," Revision 0.

The affidavit stated that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:

- a) The information summarizes a process or method, including supporting data and analysis, where prevention of its use by C.D.I's competitors without license from C.D.I. constitutes a competitive advantage over other companies;
- b) Information which, if used by a competitor, would reduce his expenditure of resources or improve his competitive position in the design, manufacture, shipment, installation, assurance of quality, or licensing of a similar product;
- c) Information which discloses patentable subject matter for which it may be desirable to obtain patent protection.

We have reviewed your application and the material in accordance with the requirements of 10 CFR 2.390 and, on the basis of the statements in the affidavit, have determined that the submitted information sought to be withheld contains proprietary commercial information and should be withheld from public disclosure.

Therefore, the above listed documents marked as proprietary, will be withheld from public disclosure pursuant to 10 CFR 2.390(b)(5) and Section 103(b) of the Atomic Energy Act of 1954, as amended.
