- I. SECY-10-0092 – South Carolina Electric & Gas Co. and South Carolina Public Service Authority (also referred to as Santee Cooper) (Virgil C. Summer Nuclear Station, Units 2 and 3), Docket Nos. 52-027-COL & 52-028-COL; Appeal of Sierra Club & Friends of the Earth (Mar. 26, 2010), Challenging LBP-10-6 (Mar. 17, 2010)

The Commission approved a Memorandum and Order responding to an appeal by Sierra Club and Friends of the Earth of LBP-10-6, a Board decision in the Summer combined license proceeding. The Memorandum and Order affirms the Board's decision in LBP-10-6 and terminates the contested portion of the proceeding.

- II. SECY-10-0094 - Entergy Nuclear Generation Co. and Entergy Nuclear Operations, Inc. (Pilgrim Nuclear Power Station) Pilgrim Watch Motion for Disqualification of Judge Abramson

The Commission approved a Memorandum and Order responding to the referral by Judge Paul Abramson of his decision denying the motion of intervenor Pilgrim Watch seeking his disqualification from this proceeding. The Memorandum and Order agrees that disqualification is not warranted.¹

- III. SECY-10-0074 – David Geisen, NRC Staff Petition for Review of LBP-09-24 (Aug. 28, 2009)

The Commission approved a Memorandum and Order responding to the Staff's petition for review of LBP-09-24. The Memorandum and Order grants review of the Staff's petition and affirms the Board's order.
