In November of 2007, the Nuclear Regulatory Commission (NRC) submitted to the Office of Management and Budget (OMB) a request to conduct a telephone survey to assess public reaction to existing protective action strategies, new protective action strategies, and the effectiveness in which these strategies are conveyed to the public. In March of 2008, OMB approved NRC's request under the title, "NRC Survey of Public Response to Emergencies" and with the clearance number 3150-0207. The current approval for this information collection expires on March 31, 2011.
