The purpose of this letter is for the Pressurized Water Reactor Owners Group (PWROG) to officially withdraw Report PSAT 4025 CF.QA.04, Rev 1, "StarFIRE Model Report," submitted May 2008, and to discuss the reasons for this action.

The PWROG submitted the StarFIRE Model Report, Revision 1 for NRC review and approval via Reference 1. The purpose of this report is to provide an improved analysis methodology to estimate the release of gaseous iodine into the environment as a fraction of the released iodine in Engineered Safety Features (ESF) leakage.

The NRC accepted this report for review in Reference 2. Additional information was requested by NC in Reference 3 and responses were provided by the PWROG in References 4 and 5.

During the review of the StarFIRE Model Report it was determined that there are questions related to iodine chemistry that can not be addressed at this time

Given that, the PWROG withdraws the StarFIRE Model Report and requests that the Staff discontinue review of this document.
