The purpose of this modification is (1) to revise the Statement of Work to add Subtask 3, (2) to increase the level of effort of the task order by 417 hours from 1,937 hours to 2,354 hours, (3) to increase the total task order ceiling by \$49,948, from \$247,890 to \$297,838, (4) to provide incremental funding in the amount of \$49,948, which increases the task order obligated amount from \$247,890 to \$297,838, and (5) to extend the period of performance through December 30, 2010.

Accordingly, the following change is hereby made:

1. Section A CONSIDERATION AND OBLIGATION—COST PLUS FIXED FEE (JUN 1988), Paragraphs (a) and (c) are hereby deleted in their entirety and replaced with the following:
