TRANSITION, UNIT 1 CYCLE 9 RELOAD SAFETY ANALYSIS FOR 105%
ORIGINAL LICENSED THERMAL POWER (TAC NO. ME3775)

Dear Mr. R. Krich:

By letter dated April 16, 2010, you submitted an affidavit dated March 30, 2010, executed by Alan B. Meginriis of AREVA NP, Inc. You requested that the information contained in the following document be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Part 2, Section 2.390:

Report ANP-2863(P), Revision 1, "Browns Ferry Unit 1 Cycle 9 Reload Safety Analysis for 105 % OLTP [original licensed thermal power]," dated March 2010.

A nonproprietary copy of this document has been placed in the Nuclear Regulatory Commission's (NRC's) Public Document Room and added to the Agencywide Documents Access and Management System Public Electronic Reading Room.

The affidavit stated that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:

Use of the information by a competitor would permit the competitor to significantly reduce its expenditures, in time or resources, to design, produce, or market a similar product or service.

The information reveals certain distinguishing aspects of a process, methodology, or component, the exclusive use of which provides a competitive advantage for AREVA NP in product optimization or marketability.

The information is vital to a competitive advantage held by AREVA NP, would be helpful to competitors to AREVA NP, and would likely cause substantial harm to the competitive position of AREVA NP.

We have reviewed your application and the material in accordance with the requirements of 10 CFR 2.390 and, on the basis of the statements in the affidavit, have determined that the submitted information sought to be withheld contains proprietary commercial information and should be withheld from public disclosure.
