Dear Ms. Annette Vietti-Cook:

The American Association of Physicists in Medicine¹ (AAPM) requests an extension to the comment period for the proposed rule: 10 CFR Part 37 on the *Physical Protection of Byproduct Material* (75FR33902) and the *Implementation Guidance for Physical Protection of Byproduct Material; Category 1 and Category 2 Quantities of Radioactive Material* (75FR47494) to January 15, 2011. The proposed rule was published for comment on June 15, 2010 and the Implementation Guidance August 6, 2010. Due to the significance and breadth of this proposed rule and the implementation guidance, we feel that extending the public comment period to January 15, 2011 will allow the stakeholder community sufficient time to review and provide detailed comments.

The basis for this request was highlighted during the recent public meeting in Austin, TX. During this meeting it was clear that a number of stakeholders had not been able to review the proposed rule and implementation guidance in sufficient detail to provide effective comments to the Commission on the issues that differ from the requirements specified under the existing orders and the proposed rule. In addition, licensees that are not currently under increased control orders may not be aware of the potential implication for their programs and therefore not aware of the need to provide comments.

Many of the stakeholders during the Austin meeting indicated they were not aware of the proposed rule until approximately a month ago when the notice of the public meetings was sent out. The recent public meeting held in Austin TX demonstrated the need for significantly more public involvement. In addition
