



## CONFERENCE SUMMARY

NRC Predecisional Enforcement Conference (PEC), Inspection Report No. 03001317/2010002

On September 1, 2010, representatives from the Department of the Army, Walter Reed Army Medical Center (WRAMC) met with NRC personnel in the Region I office located in King of Prussia, Pennsylvania, to discuss the apparent violations identified in NRC Inspection Report No. 03001317/2010001. The apparent violations included the failure to: (1) control access to two packages of radioactive materials between May 1 and 3, 2010, as required by 10 CFR 20.1802; and, (2) conduct operations such that the dose in an unrestricted area from external sources did not exceed 0.002 rem in any one hour, as required by 10 CFR 20.1301.

Additional personnel from NRC Headquarters participated by teleconference. This meeting was held at the request of Region I to obtain additional information regarding the identification of the apparent violations, in consideration of previous escalated enforcement issued to WRAMC in 2009. Although this was a Category 1 public meeting, no members of the public were in attendance.

WRAMC representatives presented a summary of the causes for the apparent violations and corrective actions that have been taken. WRAMC did not provide any significant additions or corrections to the factual information in the inspection report.
