

14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purpose of this modification is to increase the obligated amount by \$35,000.00 from \$2,385,000.00 to \$2,420,000.00. Accordingly, Paragraph (c) of Section B.3 entitled: "Consideration and Obligation" Cost plus fixed fee (JUN 1988) Alternate I (JUN 1991) is revised to read as follows:
"(c) The amount presently obligated with respect to this contract is \$2,420,000.00 of which \$2,241,383.00 represents the estimated reimbursable costs and \$178,617.00 represents the fixed fee."
All other terms and conditions remain the same.
