Purpose

In accordance with 10 *Code of Federal Regulations* (CFR) 95.19(a), USEC Inc. (USEC) hereby submits to the U.S. Nuclear Regulatory Commission (NRC) proposed page changes for the Curtiss-Wright Electro-Mechanical Corporation (Curtiss-Wright) Security Program (CW-SP-01).

Background

In a letter dated July 15, 2010 (Reference 1), NRC approved proposed changes to CW-SP-01. In May and June 2010, USEC submitted to the NRC non-substantive changes to CW-ADP-02, *Classified Distributed Information Network* (CDIN) plan, Revisions 2 and 3 (References 2 and 3 respectively) to comply with DOE M 205.1-4, *National Security System Manual*, and DOE M 205.1-3, *Telecommunication Security Manual*.

Discussion

CW-SP-01, Revision 4B, does not stipulate a time for protective force personnel to respond to alarms. NRC personnel have previously requested this information be included in standard practice procedure plans for other American Centrifuge-related facilities. This proposed change to CW-SP-01 incorporates the protective force personnel response times in section 8.1.3 and revises section 19 to comport with the changes to the CDIN plan, CW-ADP-02. Changes are marked in the right-hand margin. The changes were determined to be substantive in accordance with 10 CFR 95.19 and require NRC prior review and approval.

Enclosure 1 provides a copy of the revised pages to CW-SP-01, which contains USEC Proprietary Information, Security-Related Information, and in accordance with the guidance provided by the U.S. Department of Energy, contains Official Use Only information. Therefore, USEC requests that Enclosure 1 be withheld from public disclosure pursuant to 10 CFR 2.390(d)(1).

Action

In accordance with 10 CFR 95.19(a) the proposed changes to the Curtiss-Wright Security Program require NRC prior review and approval.
