This Draft EA and its preliminary conclusion, a Draft Finding of No Significant Impact (Draft FONSI) will be published for public comment because (1) the proposed action to renew NFS' license for 40 years is without precedent as this would be the first Category 1 facility for which this would be done, and (2) publishing the Draft EA and Draft FONSI for public comment would further the purposes of the National Environmental Policy Act, given the level of public interest in licensed activities at the NFS facility.
