Purchase Order NRC-DR-10-0162, signed July 29, 2010, is for the NRC's 2010 International Regulatory Review Service (IRRS) Mission Meeting Facility.

The purchase order states that the Bethesda North Marriott Hotel and Conference Center will provide 21 sleeping rooms for 21 people arriving October 16, 2010 and departing October 31, 2010 (to be paid by the individuals).

The purchase order also provides a meeting room package on Sunday, October 17, 2010, and again on Saturday, October 23, 2010, for 22 attendees, at a daily meeting package rate of \$109.00 per attendee, per meeting, for a total of \$2,398.00 per meeting. The total amount of the purchase order, for both meetings, is \$4,796.00.

The purpose of this modification is to increase this arrangement by one person, from 21 sleeping rooms to 22 sleeping rooms, and meeting attendees from 22 attendees to 23 attendees. The amount of the purchase order is increased by \$109.00 for each of the two meetings, or a total of \$218.00 for both meetings, thereby increasing the purchase order total from \$4,796.00 to \$5,014.00, as follows.
