This refers to our telephone conversation September 15, 2010, and your application dated June 22, 2010. Please note that we deleted Condition No. 13 from your material license. This condition is redundant since your license now has possession limits. This required renumbering of subsequent license conditions.

We also changed Subitems Nos. 7.A and 7.B on your license and should have not on your license program.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

In accordance with 10 CFR 2.390 of the NRC's "Rules of Practice," a copy of this letter and its enclosure will be available electronically for public inspection in the NRC Public Document Room or from the NRC's Agencywide Documents Access and Management System (ADAMS), accessible from the NRC Web site at <http://www.nrc.gov/reading-rm/adams.html>.


