This refers to your application dated June 22, 2010. This also refers to the telephone discussions between you and me, on September 15, 2010. We find that we will need the following additional information to continue our review of your amendment request:

We now require a total possession limit for each radionuclide requested, as well as providing the "per source" activity you need, which should match the Sealed Source and Device Registry certificate procured by the vendor. Please provide this information. It is acceptable to request more sealed sources than you may actually need immediately, to allow for some growth, so long as the request is reasonable and realistic.

We will also be changing Condition Nos. 13.D and 18. These changes should enhance your awareness of regulatory requirements and the radiation safety program elements in your license. In addition to these changes, we will be correcting some spelling errors in Subitem Nos. 9.A and B on your materials license
