The purpose of the teleconference was to discuss the MHI responses to Request for Additional Information (RAI) 4754, Revision 2. This was a follow-up call from the August 31, 2010, public teleconference. A list of attendees is enclosed.

The NRC and MHI continued the discussion on the responses to RAI 4754, Revision 2, which are related to the turbine generator overspeed trip. MHI and the NRC staff discussed MHI's draft supplementary responses to this RAI. The discussion included the turbine generator system operation. The need to identify and assess potential common cause failure modes in the turbine generator system of the overspeed trip function was also discussed. Since not all of the NRC staff's discussion points on the responses to this RAI were covered during this call, it was suggested that another follow-up teleconference or a meeting would be necessary. MHI's supplementary responses to this RAI are planned to be docketed after the discussions are completed at the next call or meeting.
