Hope Creek Generating Station License Renewal Safety Evaluation Report (SER) With Open Items

On September 30, 2010, the staff issued the SER with Open Items related to the Hope Creek Generating Station license renewal application. By letter dated August 18, 2009, PSEG Nuclear, LLC, submitted an application requesting the extension of the Hope Creek Generating Station operating license for an additional 20 years. The SER has one open item (regarding recent industry operating experience related to buried and underground piping). The staff is scheduled to meet with the Advisory Committee on Reactor Safeguards Subcommittee on November 3, 2010, to discuss the SER with Open Items.

Fire Protection Meeting on National Fire Protection Association (NFPA) 805 Frequently Asked Questions

On October 7, 2010, the staff held a Category 2 public meeting with the Nuclear Energy Institute NFPA Standard 805 Task Force, other stakeholders, and the public to discuss the Frequently Asked Questions (FAQs) related to licensees' adoption of NFPA 805 and specifically FAQ 10-0058 regarding the license amendment template for NFPA 805.

Meeting with NAC International (NAC)

On September 30, 2010, NRC staff met with representatives from NAC. NAC discussed their request for amendment 3 to the MAGNASTOR dry cask storage system, which would allow storage of damaged and high burn up fuel. They also discussed an upcoming new application for their new proprietary design for the Model No. MAGNATRAN transportation package. They plan to submit the transportation application in December 2010.

Licenses, Certifications, and Approvals for Material Licensees; Reopening of Comment Period (10 CFR Parts 30, 36, 39, 40, 51, 70, and 150) (RIN 3150-AI79, NRC-2010-0075)

On September 30, 2010, NRC reopened the public comment period for the proposed rule (75 FR 60341) that was published on July 27, 2010 (75 FR 43865). The proposed rule would amend the regulations by revising the provisions applicable to the licensing and approval processes for byproduct, source, and special nuclear material licenses and irradiators, to clarify the definitions of "construction" and "commencement of construction." The comment period for this proposed rule, which closed on September 27, 2010, is reopened and will remain open until November 29, 2010.

Major Revision to NRC Enforcement Policy (NRC-2008-0497)

On September 30, 2010, NRC published a major revision to its Enforcement Policy (75 FR 60485) in the *Federal Register* to clarify the use of terms and to update the Enforcement Policy, removing outdated information and adding information addressing enforcement issues in areas that are not currently directly addressed in the Enforcement Policy. This revision was effective September 30, 2010. The NRC intends to solicit comments on this revised policy approximately 18 months after the effective date.

Domestic Licensing of Production and Utilization Facilities; Updates to Incorporation by Reference of Regulatory Guide (RG) (10 CFR Part 50) (RIN 3150-AI37, NRC 2009-0014)

On October 5, 2010, NRC published a final rule (75 FR 61321) in the *Federal Register* that amends its regulations to incorporate by reference the latest revisions of two previously incorporated RGs approving new and revised Code Cases published by the American Society of Mechanical Engineers (ASME). The RGs, which are incorporated by reference, are RG 1.84, "Design, Fabrication, and Materials Code Case Acceptability, ASME Section III," Revision 35, and RG 1.147, "Inservice Inspection Code Case Acceptability, ASME Section XI, Division 1," Revision 16. This action allows nuclear power plant licensees and applicants for standard design certifications, standard design approvals, and manufacturing licenses under the regulations that govern license certifications, to use the Code Cases listed in these RGs as alternatives to requirements in the ASME Boiler and Pressure Vessel Code. Concurrent with this action, NRC is publishing a notice of the issuance and availability of the RGs in the *Federal Register*. As a result of these related actions, the Code Cases listed in these RGs are incorporated by reference into the NRC's regulations and are deemed to be legally binding NRC requirements. The rule is effective on November 4, 2010.
