Enclosed is Amendment No. 13 to your NRC Material License No. 21-26632-01 in accordance with your request. Please note that the changes made to your license are printed in **bold** font.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

This also refers to the voicemail message you provided to me on September 22, 2010, stating that a possession limit of 14 kilograms of depleted uranium would suffice. Your voicemail message was in response to my voicemail message left for you on September 21, 2010. Your amended license has been prepared in accordance with this updated possession limit information.

In addition, at this time I deleted Condition No. 13, as it appeared on Amendment No. 12, because your license now contains possession limits for all authorized materials and this Condition is no longer necessary. As a result, former Condition No. 14 is now renumbered "Condition No. 13," and the remaining conditions has also been renumbered.


