Thank you for bringing to our attention that you received duplicate amendment numbers. You were issued two amendments numbered 125 and subsequently, an amendment 126 was issued and should be in your possession in a few days. Also the amendments 125 addressed two different issues. In order to rectify this error we are issuing amendment no.127 which will capture content of all of the previous requests. This matter was discussed with you on October 4, 2010, and you indicated satisfaction with the proposed correction of the license. Enclosed is a corrected copy of your license (amendment no.127), we apologize for any inconvenience this error may have caused you.
