On-Shift Multiple Responsibilities

- Rule Language
 - No changes
- Interim Staff Guidance
 - events should include Design Basis
 Accidents and Design Basis Threat



Hostile Action Emergency Action Levels

- Rule Language
 - Most current EAL scheme
- Reg Guide 1.101
 - No changes



Emergency Response Organization Augmentation at Alternative Facility

- Rule Language
 - Multiple facilities collectively have required characteristics
- Interim Staff Guidance
 - Changes to reflect final rule



Licensee Coordination with Offsite Response Organizations

- Rule Language
 - Clarify the intent of the change
 - IV.A.7. Identification of, and <u>a description of the</u> assistance expected from, appropriate State, local, and Federal agencies with responsibilities for coping with emergencies. Nuclear power plant licensees shall ensure that offsite response organization resources (e.g., local law enforcement, firefighting, medical assistance) are available to respond to an emergency including hostile action at the site.
- Interim Staff Guidance
 - Changes to reflect final rule



Protective Actions for Onsite Personnel

- Rule Language
 - No changes
- Interim Staff Guidance
 - Multiple procedure usage



Challenging Drills and Exercises

- Rule Language
 - Six to eight year exercise planning cycle
 - Elimination of frequency
 - Ingestion exercise once per cycle
 - Commencement of first planning cycle
 - A licensee shall begin its first eight year exercise planning cycle no later than the date of its first biennial exercise conducted after [INSERT DATE 395 DAYS AFTER THE DATE OF PUBLICATION IN THE FEDERAL REGISTER], and that first biennial exercise must include a hostile action scenario.



Challenging Drills and Exercises

- Interim Staff Guidance
 - Sites with differing technologies or vintange
 - Clarification of no release/minimal release exercise participation
 - At least a Site Area Emergency declaration
 - NRC expectations on frequency



Alert and Notification System Backup Means

- Rule Language
 - ANS responsibility
 - No time limits on backup ANS
- Interim Staff Guidance
 - Changes to reflect final rule



Emergency Declaration Timeliness

- Rule Language
 - Capability vs Performance
 - Appropriate classification
- Interim Staff Guidance
 - 15 minute time requirement
 - Starts when indications first become available
 - Includes assessment, classification, and declaration actions
 - Validation or confirmation is part of assessment.
 - EAL thresholds related to analyses (e.g., dose assessments, chemistry sampling, and/or inspections)
 - 15-minute declaration period starts with analysis results
 - 15-min ends with emergency declaration
 - Promptly definition
 - EAL thresholds that specify a duration (eg., fire > 15 min)
 - emergency declaration process runs concurrently

Emergency Operations Facility – Performance Based Approach

- Rule Language
 - No changes
- Interim Staff Guidance
 - No changes



Evacuation Time Estimate Updating

- Rule Language
 - Change of 25% or 30 minutes,
 whichever is less
 - Provide ETEs to State and Local governments
 - Updates extended from 180 to 365 days
- NUREG/CR-7002
 - Changes made to reflect rule language



Emergency Plan Change Process

- Rule Language
 - Summary of analysis
 - "Effective" date
- RG 1.219
 - Not retroactive
 - Interaction with NRC
 - The concept of "margin"



Removal of One-Time Requirements

- Rule Language
 - No changes
- Interim Staff Guidance
 - No changes
