Dear Dr. Kopecky:

Enclosed is Amendment No. 6 to your NRC Material License No. 24-32331-01 in accordance with your request. Please note that the changes made to your license are printed in **bold** font.

This refers to your letter dated August 31, 2010, notifying the NRC of the transfer of ownership and control of License 24-32331-01, issued to Missouri Imaging Affiliates, LLC, d/b/a Clinical PET of St. Charles County. Based on the information submitted, the NRC consents to the transfer as described. The transferee should note their new responsibility and liability as an NRC licensee. Specifically, responsibility is emphasized with regard to any ongoing NRC inspection and enforcement issues, investigations, facility decontamination and decommissioning funding resources. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which the NRC expects of its licensees.
