The purpose of this modification is to provide incremental funding in the amount of \$59,000.00 thereby increasing the total obligations from \$100,000.00 to \$159,000.00. Accordingly the contract is modified as follows:

Refer to "CONSIDERATION AND OBLIGATIONS -- COST REIMBURSEMENT (JUN 1988) paragraph (b) first sentence is deleted in its entirety and replaced with the following:

" (b) The amount obligated by the Government with respect to this contract is \$159,000.00"

All other terms and conditions remain the same including the ceiling at \$182,585.18.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
