The purpose of this modification is to provide incremental funding in the amount of \$7,838.86 thereby increasing the total obligations from \$182,400.00 to \$190,238.86. Accordingly the contract is modified as follows:

" (b) The amount obligated by the Government with respect to this contract is \$190,238.86"

All other terms and conditions remain the same including the ceiling at \$190,238.86.
