The purpose of this modification is to provide incremental funding in the amount of \$35,493.00 thereby increasing the total obligations from \$109,000.00 to \$144,493.00. Accordingly the contract is modified as follows:

" (b) The amount obligated by the Government with respect to this contract is \$144,493.00"


