As you know, the State of New Jersey became an Agreement State on September 30, 2009. On December 17, 2009 NJDEP contacted Sterigenics International, Inc. (Sterigenics) to inform them of the need to issue new financial assurance documents with the State of New Jersey Department of Environmental Protection (NJDEP) as the beneficiary. Sterigenics financial assurance documents were due March 17, 2010. On May 13, 2010, NJDEP contacted STERIS to inform them that financial assurance documents that were submitted April 5, 2010 did not meet New Jersey financial assurance requirements. Due to complications experienced by Sterigenics since June, NJDEP and Sterigenics have worked together to ensure the financial assurance documents meet New Jersey regulatory requirements. This is to inform Sterigenics that Sterigenics financial assurance documents meet New Jersey financial assurance regulations.

Sterigenics financial assurance documents include:
