DAVID GEISEN'S APPLICATION FOR AWARD OF ATTORNEYS' FEES

Pursuant to 5 U.S.C. 504 and 10 C.F.R. § 12.101 et seq., David Geisen hereby applies for an award of \$258,187.50, an amount reflecting the product of the 3,442.5 attorney hours expended in Mr. Geisen's defense in the above captioned proceeding and \$75.00, the maximum dollar amount per hour allowed to be awarded under 10 C.F.R. 12.106. Mr. Geisen asserts that the above captioned proceeding is an "adversary adjudication" under 5 U.S.C. 504 and related regulations. Mr. Geisen, who has an individual net worth less than \$2 million, see Declaration of David Geisen attached hereto as Exhibit A, requests an award of fees and costs because the enforcement action taken against him by the NRC Staff in the above captioned proceeding was not substantially justified.

On January 4, 2006, David Geisen was debarred for five years under the authority of an immediately effective Enforcement Order brought by the NRC Staff alleging that he engaged in

"deliberate misconduct" in violation of 10 C.F.R. 50.5(a)(2) by knowingly making false statements to the Commission ("Order").

Mr. Geisen denied the Staff's allegations and demanded the expedited hearing to which he was entitled. Over the next twelve months, the Staff moved five times to stay that hearing at the request of the U.S. Department of Justice. Three times the Board denied the Staff's motions.² Once, the Commission affirmed the Board's decision.³ Finally, the Commission stayed the proceeding.⁴

On December 8-12, 2008, close to three years after issuance of the Order, Mr. Geisen received his hearing before this Panel. On August 28, 2009, on a vote of two to one, the Board panel found that the NRC Staff failed to "demonstrate by a preponderance of the evidence that Mr. Geisen committed the knowing misrepresentations alleged in the Enforcement Order's several charges against him," LBP-09-24, 70 NRC __ (slip op.) at 144 ("Initial Decision"), and set aside the Order. *Id.* at 145. The Panel's decision has subsequently been upheld by the Commission. *In the Matter of David Geisen*, CLI-10-23 (Aug. 27, 2010).

In the Initial Decision, this Panel thoroughly outlined the reasons that the Staff's allegations against Mr. Geisen failed as a matter of fact and law. The analysis set forth in the Initial Decision makes clear that the Staff's position was not substantially justified. Moreover, the procedural history of this case compels the conclusion that the Staff, at the behest of the Department of Justice, unreasonably protracted the proceeding in a manner than unnecessarily

increased the cost of Mr. Geisen's legal defense. For those reasons, Mr. Geisen should be awarded fees and costs pursuant to 10 C.F.R. § 12.101 et seq.
