U.S. NUCLEAR REGULATORY COMMISSION LICENSE SUB 1435

Dear Mr. Himsl:

I am writing in response to your letter, dated October 21, 2010, [Agencywide Documents Access and Management System (ADAMS) ML103010264] to Ms. Yolande Norman informing the U.S. Nuclear Regulatory Commission (NRC) staff of the replacement of Mr. Paul Cloud with Dr. David Goldblum as the Radiation Safety Officer (RSO) for the Jefferson Proving Ground (JPG) (USNRC License SUB-1435). Your letter included NRC Form 313, but did not include information demonstrating that Dr. Goldblum meets the minimum qualifications for an RSO described in NRC guidance and your license.

License Condition 11 A of SUB-1435 outlines the minimum qualifications for the JPG RSO. Guidance in NUREG-1556 "Consolidated Guidance about Materials Licenses" and NUREG-1757 "Consolidated Decommissioning Guidance" discuss the minimum qualifications for an RSO, and state that licensees should provide information demonstrating that an RSO meets these minimum qualifications. Therefore, please provide information demonstrating that Dr. Goldblum meets the qualifications outlined in NRC guidance and condition 11A of your license as soon as possible, but no later than 30 days from the date of this letter.

In accordance with 10 CFR 2.390 of the NRC's "Rules of Practice," a copy of this letter will be available electronically for public inspection in the NRC Public Document Room or from the Publicly Available Records component of NRC's ADAMS. ADAMS is accessible from the NRC website at <http://www.nrc.gov/reading-rm/adams.html>.
