In order to collect information for the next Chief FOIA Officer Report we must provide examples or statistics illustrating NRC's actions taken in making discretionary releases of records or partial releases when full disclosure is not possible. In addition, in efforts to continue NRC's compliance with the Attorney General's FOIA Guidelines regarding discretionary disclosures of information and to not withhold records simply because a FOIA exemption might allow withholding, the format for the "Memorandum to: FOIA/PA Caseworker, FOIA/PA Section," has been revised to include a line to be annotated when you make discretionary disclosures of information. Discretionary releases of information would primarily apply to information which would have qualified for withholding under either Exemption 2 (high) or Exemption 5. A copy of the revised memorandum is attached.
