Pursuant to Section C.1 of “CAB Case Management Order #2,” issued on September 30, 2009, the County of Inyo, California (“Inyo County”) hereby submits this Certification of No Additional Party Witnesses. Two (2) of Inyo County’s contentions, INY-SAFETY-003 and INY-NEPA-006, have been admitted to this proceeding and are identified in CAB Case Management Order #2 as being associated with Phase I discovery.
