Dear Mr. Pollock:

On September 17, 2010, the U.S. Nuclear Regulatory Commission (NRC) completed a security baseline inspection at your Indian Point Energy Center, Units 2 and 3. The inspection covered one or more of the key attributes of the security cornerstone of the NRC's Reactor Oversight Process. The enclosed inspection report documents the inspection results, which were discussed on September 17, 2010, with Mr. Pat Conroy, Director Nuclear Safety Assurance.

The inspection examined activities conducted under your licenses as they relate to security and compliance with the Commission's rules and regulations and with the conditions of your licenses. The inspectors reviewed selected procedures and records, observed activities, and interviewed personnel.

This report documents one NRC-identified finding and one self-revealing finding of very low security significance (i.e., Green as determined by the Baseline Security Significance Determination Process). The deficiencies were promptly corrected or compensated for, and the plant was in compliance with applicable physical protection and security requirements within the scope of this inspection before the inspectors left the site.

The findings had cross-cutting aspects in the area of Human Performance because Entergy personnel did not use human error prevention techniques and failed to use conservative assumptions in decision making [H.4(a) and H.1(b)]. If you disagree with the cross-cutting aspects assigned to any finding in this report, you should provide a response within 30 days of the date of this inspection report, with the basis for your disagreement, to the Regional Administrator, Region I, and the NRC Resident Inspectors at Indian Point Energy Center.
