SUBJECT: LICENSE AMENDMENT

Please find enclosed Amendment No. 22 to NRC License No. 42-27055-01 **correcting a mailing address for your facility in Weston, West Virginia, and authorizing the release for unrestricted use of a field office in Beckley, West Virginia. The supporting documentation provided by you stated that all radioactive material possessed under this license had been transferred to other Schlumberger facilities and that the swipe samples of the storage pit resulted in less than 0.005 microcuries of removable contamination. In addition, you conducted a final status radiation survey. Radiation levels from all surveyed stations indicated background radiation readings. Based on this information, the staff concluded that all licensable radioactive material has been removed from this facility. Your facility located at 600 Industrial Drive, Beckley, West Virginia, is suitable for unrestricted use in accordance with 10 CFR 20.1402, "Radiological Criteria for Unrestricted Use." In addition, this amendment incorporates into the license the corporate ownership reorganization as described in letters dated September 10, 2010 and October 21, 2010.**

An environmental assessment for this action is not required, since this action is categorically excluded under 10 CFR 51.22(c)(14)(viii). Pursuant to NRC's RIS 2005-31, the enclosed materials license will not be made publicly available.

NRC expects licensees to conduct their programs with meticulous attention to detail and a high standard of compliance. Because of the serious consequences to employees and the public that can result from failure to comply with NRC requirements, you must conduct your radiation safety program according to the conditions of your NRC license, representations made in your license application, and NRC regulations. In particular, note that you must:

1. Operate by NRC regulations 10 CFR Part 19, "Notices, Instructions and Reports to Workers: Inspection and Investigations," 10 CFR Part 20, "Standards for Protection Against Radiation," and other applicable regulations.
2. Notify NRC in writing of any change in mailing address.

3. By 10 CFR 30.36(d) and/or license condition, notify NRC, promptly, in writing, and request termination of the license:
  - a. When you decide to terminate all activities involving materials authorized under the license whether at the entire site or any separate building or outdoor area;
  - b. If you decide not to acquire or possess and use authorized material; or
  - c. When no principal activities under the license have been conducted for a period of 24 months.
  
4. Request and obtain a license amendment before you:
  - a. Change Radiation Safety Officers;
  - b. Order byproduct material in excess of the amount, radionuclide or form authorized on the license;
  - c. Add or change the areas or address(es) of use identified in the license application or on the license; or
  - d. Change the name or ownership of your organization.

NRC will periodically inspect your radiation safety program. Failure to conduct your program according to NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC may result in enforcement action against you. This could include issuance of a notice of violation; imposition of a civil penalty; or an order suspending, modifying, or revoking your license as specified in the NRC Enforcement Policy.
